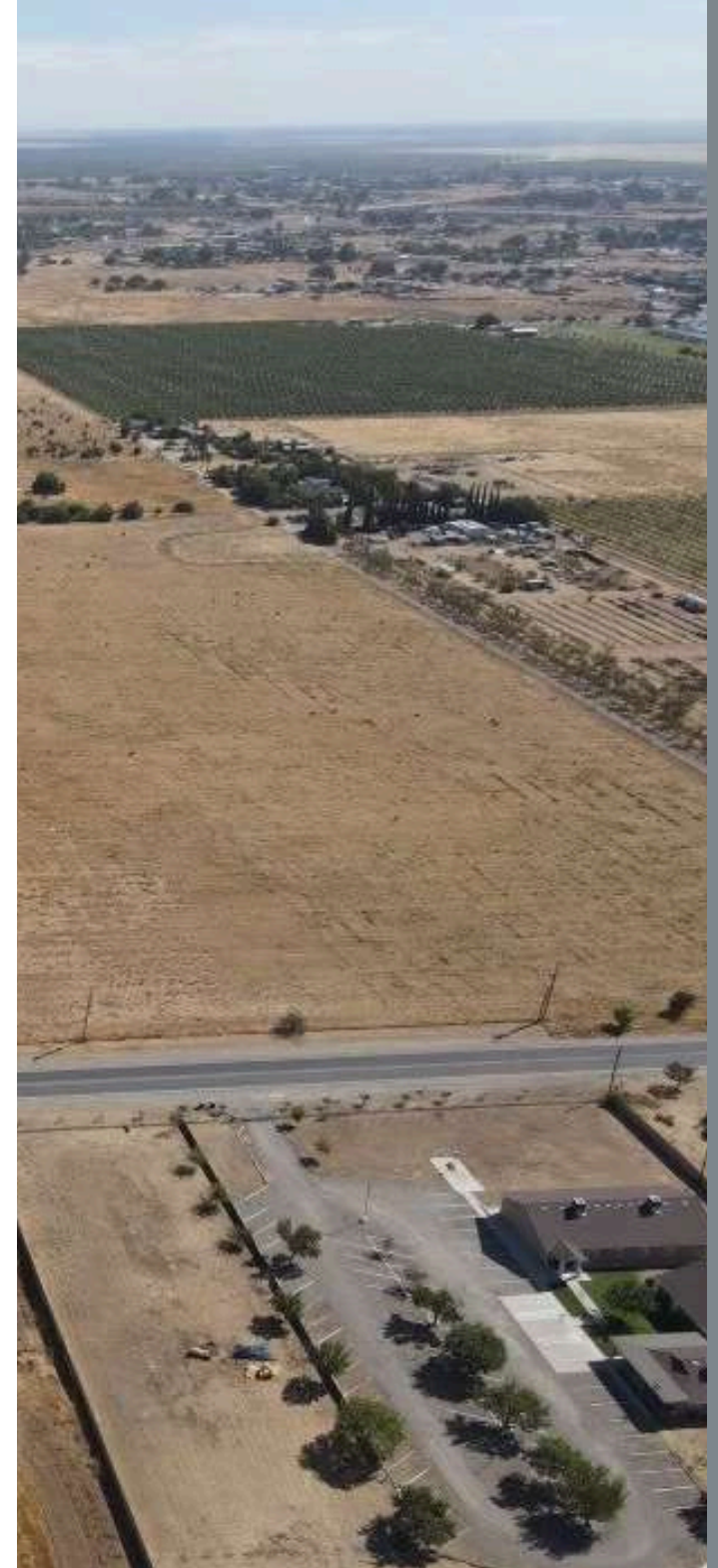

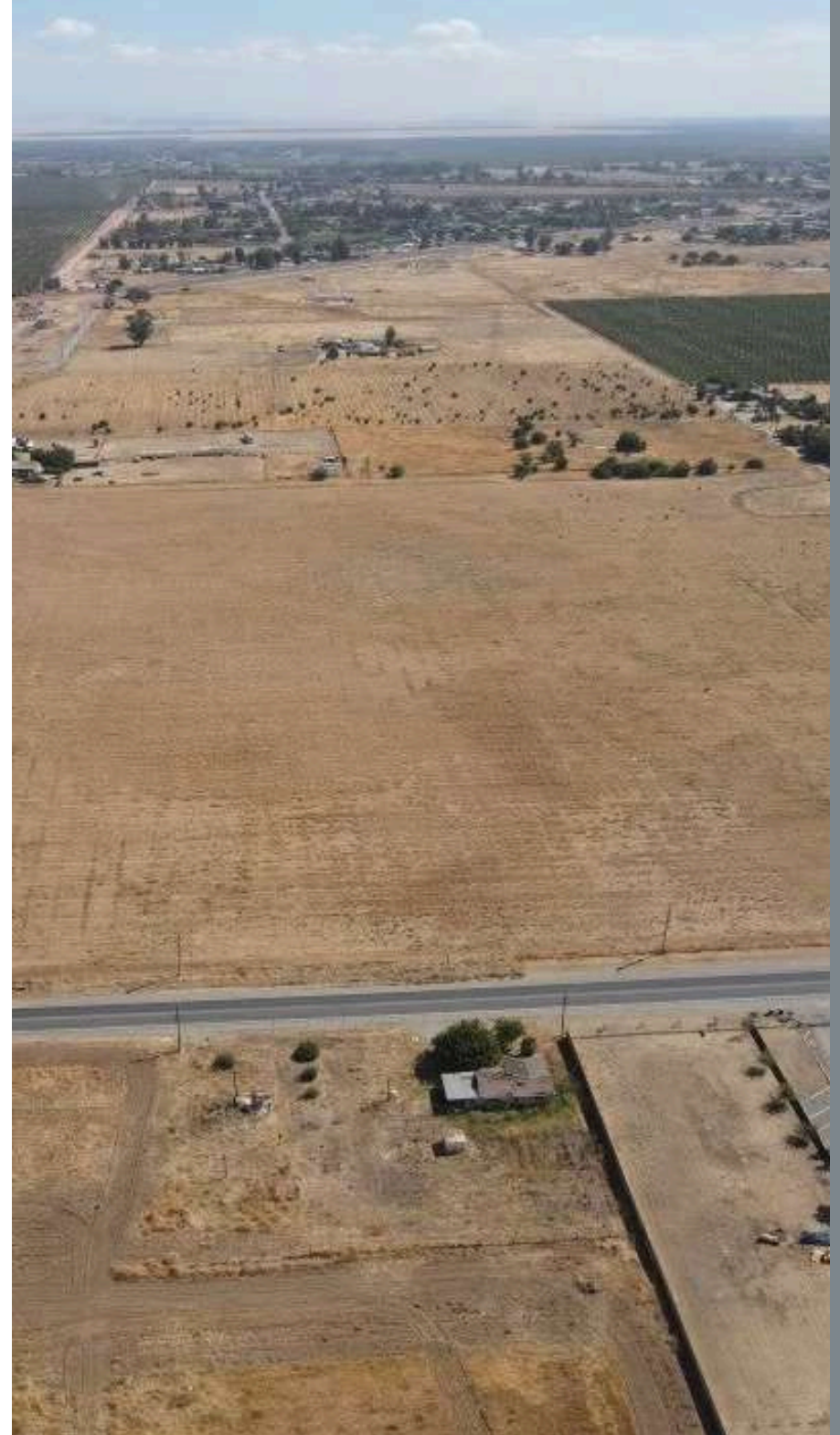

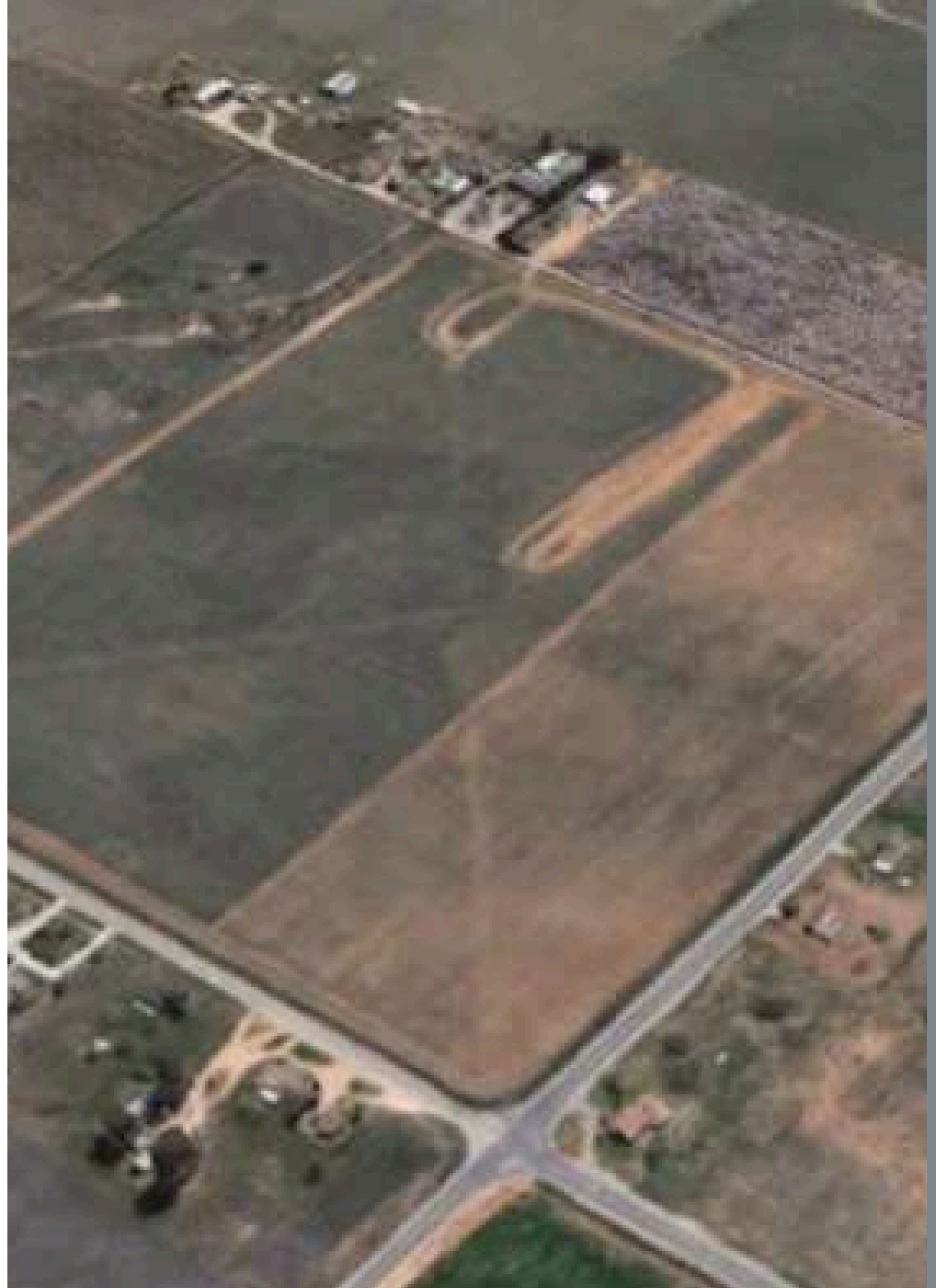

## MADERA, CA

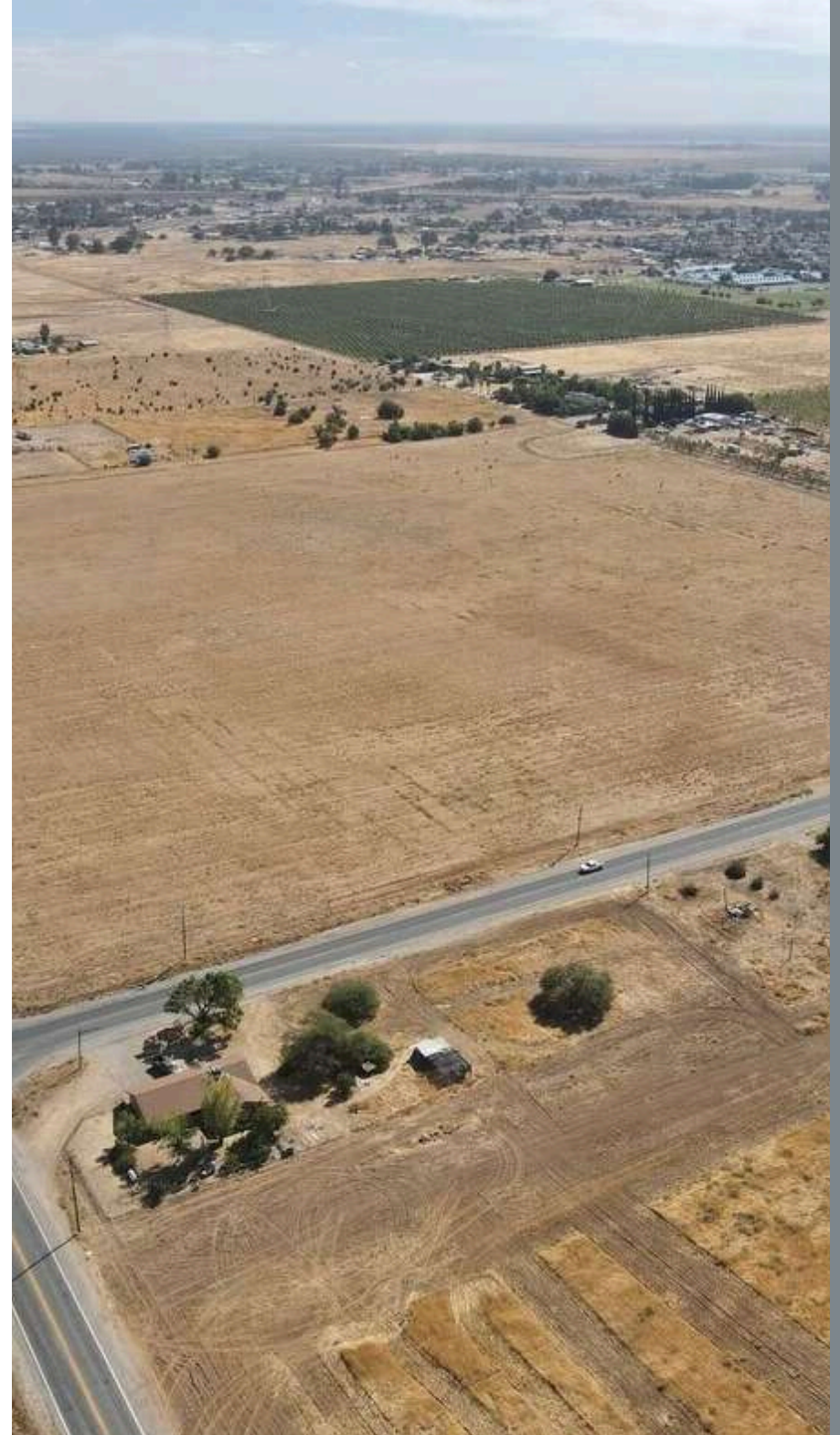
