


Overview

Average & Median Sales Price

The median sales price in February 2023 was \$515,000, up 6.08% from \$485,500 from the previous month and 16.78% higher than \$441,000 from February 2022. The February 2023 median sales price was at its highest level compared to February 2022 and 2021. The average sales price in February 2023 was \$572,124, up 8.01% from \$529,682 from the previous month and 12.84% higher than \$507,003 from February 2022. The February 2023 average sale price was at its highest level compared to February 2022 and 2021.



Sales Price / List Price Ratio

The sales price/list price ratio is the average sale price divided by the average list price for sold properties expressed as a percentage. If it is above 100%, homes are selling for more than the list price. If it is less than 100%, homes are selling for less than the list price. The February 2023 sales price/list price ratio was 99.24%, equal to the previous month and equal to February 2022.



Number of Properties Sold & Absorption Rate

The number of properties sold in February 2023 was 81, down -10.0% from 90 from the previous month and -34.68% lower than 124 from February 2022. The February 2023 sales were at its lowest level compared to February 2022 and 2021. Absorption rate is the avg number of sales per month divided by the total number of available properties.
