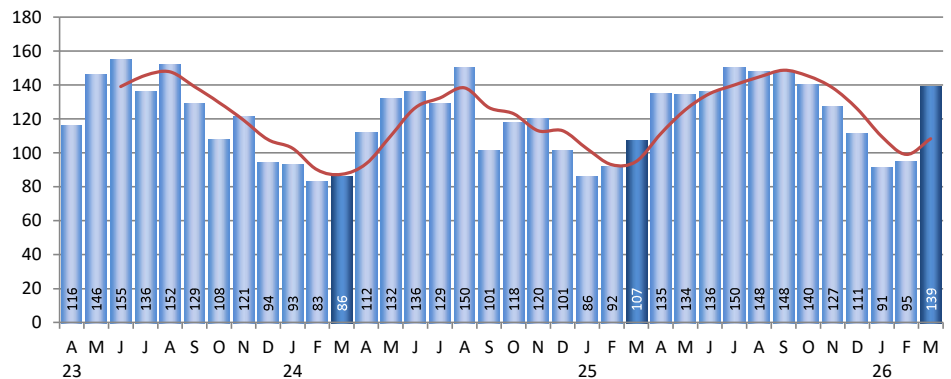

Property Sales

March Property sales were 139, up 29.9% from 107 in March of 2025 and 46.3% higher than the 95 sales last month. March 2026 sales were at their highest level compared to March of 2025 and 2024. March YTD sales of 325 are running 14.0% ahead of last year's year-to-date sales of 285.

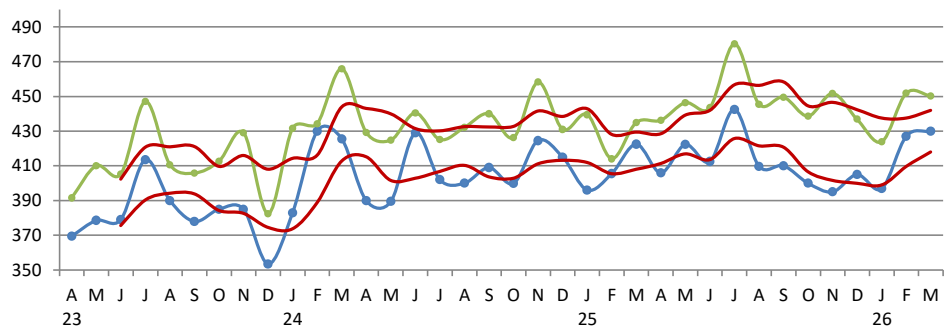
Number of Properties Sold



Prices

The Median Sales Price in March was \$429,990, up 1.8% from \$422,500 in March of 2025 and up 0.7% from \$427,000 last month. The Average Sales Price in March was \$450,243, up 3.5% from \$434,917 in March of 2025 and down 0.4% from \$451,830 last month. March 2026 ASP was at a mid range compared to March of 2025 and 2024.

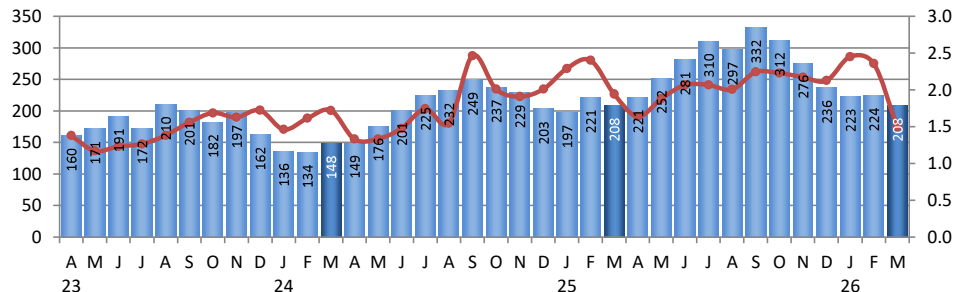
Median Sales Price and Average Sales Price



Inventory & MSI

The Total Inventory of Properties available for sale as of March was 208, down 7.1% from 224 last month and equal to 208 in March of last year. March 2026 Inventory was at its highest level compared with March of 2025 and 2024.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The March 2026 MSI of 1.5 months was at its lowest level compared with March of 2025 and 2024.

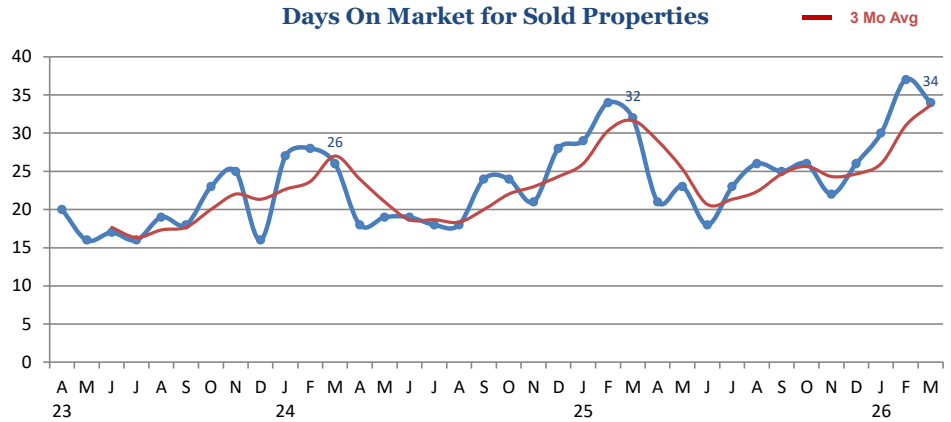

Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for March was 34, down 8.1% from 37 days last month and up 6.3% from 32 days in March of last year. The March 2026 DOM was at a mid level compared with March of 2025 and 2024.

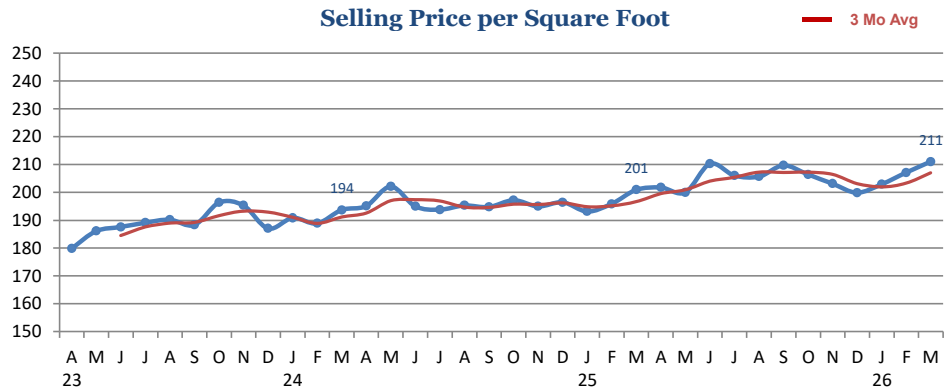
Days On Market for Sold Properties



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The March 2026 Selling Price per Square Foot of \$211 was up 1.9% from \$207 last month and up 5.0% from 201 in March of last year.

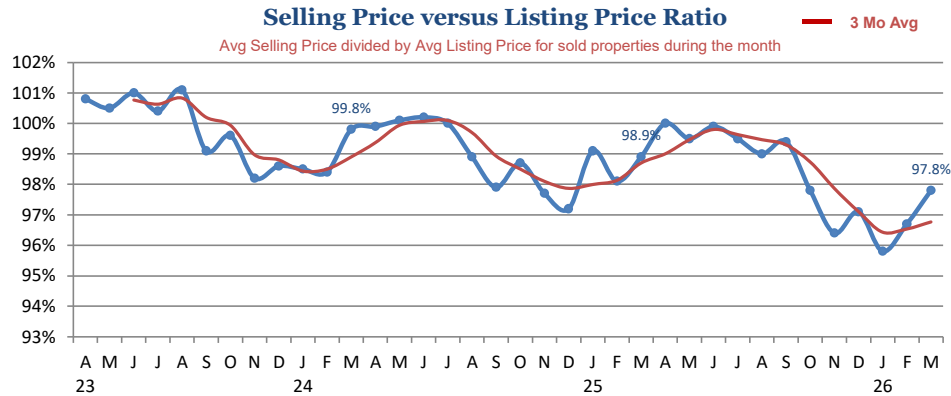
Selling Price per Square Foot



Selling Price vs Original Listings Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The March 2026 Selling Price vs Original List Price of 97.8% was up from 96.7% last month and down from 98.9% in March of last year.

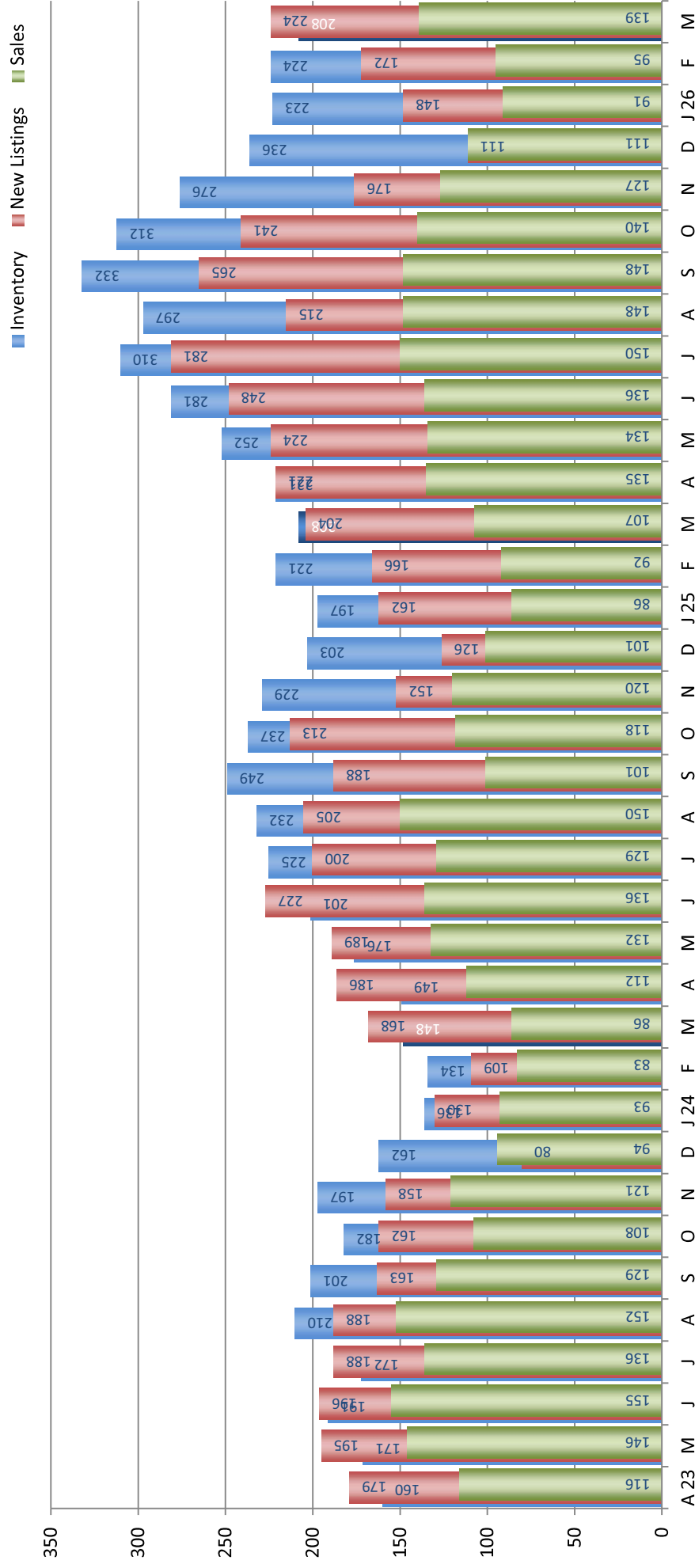
